## **EMERGENCY PREPAREDNESS IN PUBLIC HEALTH**

## GRADUATE CERTIFICATE: EMERGENCY PREPAREDNESS IN PUBLIC HEALTH

After the attacks of September 11, 2001 and the subsequent anthrax incidents across the nation, it became clear that many employees, emergency personnel, educators, managers, and public health professionals must have the necessary training to handle public health emergencies of all kinds. The Public Health Security and Bioterrorism Preparation and Response Act (June 2002) notes the need to better educate professionals regarding the protection of workers and the general population during emergencies.

This certificate is designed for public, environmental, and occupational health professionals; emergency personnel; and managers and educators who need to upgrade their skills to protect people during emergencies. Certificate courses provide a solid preparation in epidemiology and public health practice as well as the development of skills needed to identify, measure, and control environmental hazards. The program focuses on emergency preparedness and how to assess and communicate public health risks from chemical and biological hazards.

#### PROGRAM OF STUDY

This certificate program consists of six, three-credit courses for a total of 18 credits. In the fall and spring semesters, courses meet during convenient, once-a-week evening time slots designed to accommodate students' needs as working professionals. Special condensed course formats are often available during the summer, and students can complete all requirements for the certificate in a single calendar year. Each course in the certificate

program combines conventional classroom instruction and hands-on learning with Internet assistance to bring course materials, activities, and assignments directly to students at their place of study. The required courses are listed below:

ENV 545 Risk Assessment

ENV 551 Environmental Toxicology

ENV 570 Emergency Preparedness

ENV 575 Bioterrorism and Public Health

HEA 520 Public Health Epidemiology

# ADDITIONAL CERTIFICATE REQUIREMENT

Students must hold a valid 40-hour certification in hazardous waste operations and emergency response (OSHA 29 CFR Part 1910.120) and a valid certificate in first aid/CPR at the time they receive the emergency preparedness certificate from WCU. These certifications are available at WCU or may be obtained elsewhere.

#### **BENEFITS OF THE PROGRAM**

The courses in this certificate program are designed to enhance students' expertise in all aspects of emergency management including mitigation, preparedness, response, and recovery. In particular, students will be better qualified to

- identify and assess threats and risks to various populations, both public and private, associated with major physical, chemical, and biological disease agents;
- anticipate and properly react to small and large environmental accidents;
- conduct thorough and effective planning to identify steps for emergency relief and rapid, appropriate

- decision making and response during public health emergencies;
- effectively communicate risk to populations and actively develop, evaluate, and manage risk reduction strategies;
- lead business and community sectors through all elements of emergency preparedness and compassionately guide individuals and organizations through emergency recovery; and
- incorporate emergency preparedness into the daily fabric of public and private organizations, stressing integration with the work habits of other professionals.

# ADMISSION REQUIREMENTS AND MASTER'S STUDIES

To be considered for the certificate in emergency preparedness in public health, applicants must meet all the admission requirements for WCU graduate study (a minimum 2.8 GPA in an undergraduate degree and 2.8 GPA in the major area of study). Applicants will typically have undergraduate and/or graduate degrees in a science, engineering, or health-related field although outstanding individuals from other areas may also be admitted. Once the certificate has been satisfactorily completed, students may elect to pursue the master's degree in public health (M.P.H.). Additional courses in public health and environmental health, as well as a six-credit individualized, applied learning experience are required for the degree.
