

GOAL TEAM UPDATE: DEVELOPMENTAL COURSES

Results from Inquiry Process

- 17% equity gap in 2nd year retention
- Multifaceted need to enhance academic support
 - Learning loss associated with COVID-19 pandemic
 - Move away from developmental courses
- Academic supports need to be designed to meet students where they are



MOVING FORWARD: DEVELOPMENTAL COURSES

Recommendations

- Sunset Developmental Courses
- Increase & Augment Student Academic Support
- Monitor Data

Next Steps/Future Focus

- Monitor data regarding intro of MAT112
- Create additional co-curricular courses & pathways allowing for transition away from Q20 & Q30 courses
- Develop base funding sources for academic support programs

GOAL TEAM UPDATE: HOLD REFORM

Results from Inquiry Process

- 8% equity gap in holds preventing registration
- Identified 58 existing registration holds focus on 3:
 - Financial Terms and Conditions (FTC)
 - Advising Hold (NEN)
 - Miscellaneous Bursar Hold (MSC)
- Confusion related to what holds mean & how to remove
- Time to remove is variable
- No policy guiding implementation, communication, etc.

MOVING FORWARD: HOLD REFORM

Recommendations

- Goal Team: Transparency
 - Type, why added, how to resolve, & prompt removal
- Advisory Board: Policy & framework updates
 - Policy to eliminate holds
 - Limit instances

Next Steps/Future Focus

 Implementing Recommendations in RamPortal - March 2024

• Implementation of new policy - Spring 2024 - Spring 2025



GOAL TEAM UPDATE: RETENTION & MICRO GRANTS

Results from Inquiry Process

- 10.9% equity gap in unpaid balances
- No centralized method for distribution
- Amount of funding is variable
- Campus largely unaware of funds available
- Burden placed on students
 - Telling story & restricted application
- Little data available



MOVING FORWARD: RETENTION & MICRO GRANTS

Recommendations


• Centralization of funds: strategy, clarity & data collection

- Improved student experience: coordination, avoid extra steps
- Increased funding: new funding categories, quick access


Next Steps/Future Focus

- Develop prioritization & implementation strategies
- Develop & implement communication strategy to better inform campus
- Develop funding sources for microgrants


